The Master of Arts program with a major in clinical psychology has four learning outcomes which are evaluated annually. Assessment tools include the program's comprehensive examination and external practicum supervisors' evaluations of students' performance. The program director conducts the assessment and shares results with the University Assessment Team.

4. Student Learning Outcomes -Which student learning outcome(s) from the assessment plan filed with the University Assessment Team is/are being reported on in this report? Include the corresponding benchmark(s) for each outcome.

Student Learning Outcome 1: Students will demonstrate broad based knowledge of psychology and specific knowledge of clinical psychology.

Measurement: All students will pass the program's comprehensive examination during their third-year of graduate study. A passing grade is 60% of 225 items answered correctly (consistent with the standards of the national psychology licensing examination for master's level psychology practitioners). The comprehensive examination includes content from all courses students completed throughout their time in the program.

AY 2023-24: The one third-year student passed the comprehensive examination.

Student Learning Outcome 2: Upon completion of a 500-hr practicum, all students will Demonstrate master's-level competence in psychotherapy.

Measurement: On the MA Clinical Psychology Practicum Student Evaluation Form, external practicum supervisors will rate students' performance on at least 80% of items regarding psychotherapy as "3- Acceptable and Professional" or above.

AY 2023-2024: Three students were on practicum during AY 2023-2024. One student completed their practicum during AY 2023-2024 and met the benchmark with 100% of items regarding psychotherapy rated as "3- Acceptable and Professional" or above.



No action planned. One student completed practicum during the AY 2024-2025 (and will be included in next year's report). The third student is still on practicum and anticipates completing practicum during Winter 2025 semester (and will be included in next year's report).

Student Learning Outcome 3: Upon completion of a 500-hr practicum, all students will Demonstrate master's-level competence in psychological assessment.

Measurement: On the MA Clinical Psychology Practicum Student Evaluation Form, external practicum supervisors will rate students' performance on at least 80% of items regarding psychological assessment as "3- Acceptable and Professional" or above.

AY 2023-2024: Three students were on practicum during AY 2023-2024. One student completed their practicum during AY 2023-2024 and met the benchmark with 100% of assessment items rated as "3- Acceptable and Professional" or above.

No action planned. One student completed practicum during the AY 2024-2025 (and will be included in next year's report). The third student is still on practicum and anticipates completing practicum during Winter 2025 semester (and will be included in next year's report).

Student Learning Outcome 4: Upon completion of a 500-hr practicum, all students will Demonstrate master's-level competence in professional and personal characteristics.

Measurement: On the MA Clinical Psychology Practicum Student Evaluation Form, external practicum supervisors will rate students' performance on at least 80% of items regarding professional and personal characteristics as "3-Acceptable and Professional" or above.

AY 2023-2024: Three students were on practicum during AY 2023-2024. One student completed their practicum during AY 2023-2024 and met the benchmark with 100% of professional and personal characteristics rated as "3-Acceptable and Professional" or above.

No action planned. One student completed practicum during the AY 2024-2025 (and will be included in next year's report). The third student is still on practicum and anticipates completing practicum during Winter 2025 semester (and will be included in next year's report).
