The Masters in Architecture program has three student learning outcomes, with all outcomes assessed each year. Faculty assess student learning outcomes using direct measures from embedded assignments (e.g. thesis defense, thesis book, and assignments using course rubrics)

Referencing the MArch in Architecture Program Assessment Plan on file with the University Assessment Team, three outcomes are being assessed in this cycle.

Student Learning Outcome #1: PROFESSIONALISM & ETHICS: The program ensures that students understand professional ethics, the regulatory requirements, the fundamental business processes relevant to architecture practice in the United States, and the forces influencing change in these subjects.

Benchmark: 85% of students will achieve a letter grade of B or higher on ARCH 5190: Profession of Architecture: Assignment 1: Mission Statement within Business Plan for hypothetical architecture firm using the standard UDM letter grade rubric.

Student Learning Outcome #2: COMMUNICATION: Gain the ability to effectively represent and explain data analysis and the position toward the research topic via a thesis book that is graphically compelling, clearly organized, and well crafted. Benchmark 1: 85% of students will achieve a grade of a letter grade of B or higher on their Masters Supplement I, ARCH 5110: Thesis Book on standard UDM letter grade rubric. Benchmark 2: 100% of students will achieve a letter grade of B or higher on their Masters Supplement II, ARCH 5210: Thesis Book on standard UDM letter grade rubric.



Student Learning Outcome #3: CRITICAL THINKING & PROBLEM SOLVING: The program instills in students the role of the design process in shaping the built environment and conveys the methods by which design processes integrate multiple factors, in different settings and scales of development, from buildings to cities. Benchmark 1: 75% of students will achieve a grade of Met or higher on their Preliminary Thesis Defense using the standard rubric (Unmet, Partially Met, Met). Benchmark 2: Benchmark: 85% of students will achieve a grade of Met or higher on their Final Thesis Defense using the standard rubric (Unmet, Partially Met, Met).

Student Learning Outcome #1: PROFESSIONALISM & ETHICS: 100% (30/30) of the ARCH 5190: Profession of Architecture students earned a rubric equivalent score of C or better on B or higher on ARCH 5190: Profession of Architecture: Assignment 1: Mission Statement within Business Plan, which is above the 85% benchmark for the group of students.

Student Learning Outcome #2: COMMUNICATION: Benchmark 1: 100% (30/30) of the students earned a letter grade of B or higher on their Masters Supplement I, ARCH 5110: Thesis Book, which is above the 85% benchmark for the group of students. Benchmark 2: 100% (30/30) earned a letter grade of B or higher on their Masters Supplement II, ARCH 5210: Thesis Book which meets the 100% benchmark for the group of students.

Student Learning Outcome #3: CRITICAL THINKING & PROBLEM SOLVING: Benchmark 1: 100% (30/30) students achieved a grade of Met or higher on their Preliminary Thesis Defense, which is above the 75% benchmark for the group of students. Benchmark 2: 100% (30/30) students achieved a grade of Met or higher on their Final Thesis Defense, which is above the 85% benchmark for the group of students.
