The MS Physician Assistant program has five student learning outcomes, with all outcomes assessed each year. Faculty assess student learning outcomes using direct measures from embedded assignments (exams, quizzes, and assignments using scoring rubrics).

Referencing the MS Physician Assistant Program Assessment Plan on file with the University Assessment Team, all outcomes are being assessed in this cycle.

**Student Learning Outcome 1** - Clinical and Technical Skills - PA students will approach a patient of any group, in any setting, to elicit a detailed and accurate history, perform an appropriate physical examination, delineate problems, and record and present the data. The benchmarks for success are at least 90% of students will achieve a minimum score of 80% or better on assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5360, PAS 5370, PAS 5380, PAS 5400 to PAS 5409, PAS 5870, PAS 5880, and PAS 5890. Methods of assessment include written examinations, practical examinations, patient case presentations, and written documentation assignments. All students will achieve a minimum score of 3.5/5 or better on a Likert scale on each end of rotation (EOR) preceptor evaluation of overall preparedness in PAS 5400 to PAS 5409.

**Student Learning Outcome 2** - Clinical Reasoning and Problem-Solving Abilities - PA students will demonstrate the ability to utilize up-to-date scientific evidence to inform clinical reasoning and clinical judgment. The benchmarks for success are at least 90% of students will achieve a minimum score of 80% or better on all assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5240, PAS 5250, PAS 5260, PAS 5400 to PAS 5409, PAS 5870, PAS 5880, PAS 5890, and HLH 5500. Methods of assessment include written examinations, practical examinations, patient case presentations, research paper, and written documentation assignments. All students will achieve a minimum score of 3.5/5 or better on a Likert scale on each EOR preceptor evaluation of clinical reasoning and judgment, oral presentation skills, and differential diagnosis in PAS 5400 to PAS 5409. At least 90% of students will achieve a minimum score of 70% or better on written EOR examinations. At least 90% of students will achieve a passing score on the end of curriculum (EOC) written examination. At least 90% of students will achieve a passing score on their first attempt of the Physician Assistant National Certifying Examination (PANCE).



Passing scores for EOC and PANCE exams are determined annually by the Physician Assistant Education Association.

**Student Learning Outcome 3** - Medical Knowledge - PA students will apply core medical knowledge needed to care for patients. The benchmarks for success are at least 90% of students will achieve a minimum score of 80% or better on all assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5240, PAS 5250, PAS 5260, PAS 5360, PAS 5370, PAS 5380, PAS 5400 to 5409, PAS 5870, PAS 5880, PAS 5890, BIO 5340, BIO 5350, HLH 5300, and HLH 5310. Methods of assessment include written examinations, practical examinations, patient case presentations, and written documentation assignments. All students will achieve a minimum score of 3.5/5 or better on a Likert scale on each EOR preceptor evaluation of foundational medical knowledge and differential diagnosis in PAS 5400 to PAS 5409. At least 90% of students will achieve a minimum score of 70% or better on written EOR examinations. At least 90% of students will achieve a passing score on the end of curriculum (EOC) written examination. At least 90% of students will achieve a passing score on their first attempt of the PANCE. Passing scores for EOC and PANCE exams are determined annually by the Physician Assistant Education Association.

**Student Learning Outcome 4** - Interpersonal Skills - PA students will demonstrate sensitivity to patient health needs and effectively communicate with patients, family members, and the health care team to address the patient's health needs. The benchmarks for success are at least 90% of students will achieve a minimum score of 80% or better on all assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5400 to PAS 5409, HLH 5700, and HLH 5320. Methods of assessment include written examinations, practical examinations, reflection paper, patient case presentations, discussion boards, and a community health project. At least 90% of students will achieve a minimum score of 3.5/5 or better on a Likert scale on each EOR preceptor evaluation of interpersonal skills in PAS 5400 to PAS 5409. All students will be members of the William Beaumont Society, the PA program student service organization.

**Student Learning Outcome 5** - Professional Behaviors – PA students will demonstrate accountability to patients, society, and the profession. The benchmarks for success are at least 90% of students will achieve a minimum score of 80% or better on all assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5400 to PAS 5409, HLH 5700, and HLH 5320. Methods of assessment include written examinations, reflection paper, professionalism rubric, discussion boards, and a community service project. At least 90% of students will achieve a minimum score of 3.5/5 or better on a Likert scale on each EOR preceptor evaluation of professionalism in PAS 5400 to PAS 5409. All students will be members of the Michigan Academy of Physician Associates and the American Academy of Physician Associates.

7. **Results, Planned Actions, and/or Actions Taken** -Briefly summarize the assessment results, how they relate to benchmark(s), and how you are using them to enhance student learning and improve program quality.

During the 2023-2024 academic year, the clinical year cohort was 60 students, and the didactic year cohort was 94 students. One student in the clinical year took a leave of absence (LOA) due to family illness. One didactic year student was dismissed after fall 2023 and one voluntarily withdrew after winter 2024 due to birth of a child.

**Student Learning Outcome 1** – 98.4% (123/125) of students achieved an 80% or better on all assignments and assessments in PAS 5100, PAS 5240, PAS 5360, PAS 5200, PAS 5250, PAS 5370, PAS 5300, PAS 5260, PAS 5380, PAS 5870, PAS 5880, and PAS 5890. 100% (59/59) achieved a minimum score of 3.5/5 or better on a Likert scale on each EOR preceptor evaluation of clinical reasoning and judgment, oral presentation skills, and differential diagnosis in PAS 5400 to PAS 5409. One student in the clinical year cohort has not completed all rotations due to LOA.

**Student Learning Outcome 2** – 98.1% (151/154) of students achieved an 80% or better on all assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5240, PAS 5250, PAS 5260, PAS 5400 to PAS 5409, PAS 5870, PAS 5880, PAS 5890, and HLH 5500. Methods of assessment include written examinations, practical examinations, patient case presentations, research paper, and written documentation assignments. 100% (59/59) achieved a minimum score of 3.5/5 or better on a Likert scale on each EOR preceptor evaluation of clinical reasoning and judgment, oral presentation skills, and differential diagnosis in PAS 5400 to PAS 5409. One student in the clinical year cohort has not completed all rotations due to LOA. 100% (59/59) achieved a minimum score of 70% or better on written EOR examinations. One student in the clinical year cohort has not taken all EOR examinations due to LOA. 98.3% (58/59) of students achieved a passing score on the end of curriculum (EOC) written examination. One student has not taken the end of curriculum exam yet due to LOA. 100% (55/55) of students achieved a passing score on their first attempt of the Physician Assistant National Certifying Examination (PANCE). Five students in the clinical year cohort have not taken the PANCE yet. Passing scores for EOC and PANCE exams are determined annually by the Physician Assistant Education Association.

**Student Learning Outcome 3** - 98.1% (151/154) of students achieved an 80% or better on all assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5240, PAS 5250, PAS 5260, PAS 5360, PAS 5370, PAS 5380, PAS 5400 to 5409, PAS 5870, PAS 5880, PAS 5890, BIO 5340, BIO 5350, HLH 5300, and HLH 5310. One student in the clinical year cohort has not completed all rotations due to LOA. 100% (59/59) achieved a minimum score of 70% or better on written EOR examinations. One student in the clinical year cohort has not taken all EOR examinations due to LOA. % of students will achieve a passing score on the end of curriculum (EOC) written examination. 100% (55/55) of students achieved a passing score on their first attempt of the Physician Assistant National Certifying Examination (PANCE). Five students in the clinical year cohort have not taken the PANCE yet. Passing scores for EOC and PANCE exams are determined annually by the Physician Assistant Education Association.



**Student Learning Outcome 4** - 98.1% (151/154) of students achieved a minimum score of 80% or better on all assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5400 to PAS 5409, HLH 5700, and HLH 5320. Methods of assessment include written examinations, practical examinations, reflection paper, patient case presentations, discussion boards, and a community health project. 100% (59/59) of students will achieve a minimum score of 3.5/5 or better on a Likert scale on each EOR preceptor evaluation of interpersonal skills in PAS 5400 to PAS 5409. One student in the clinical year cohort has not completed all rotations due to LOA. 100% of students are members of the William Beaumont Society, the PA program student service organization.

**Student Learning Outcome 5** - 98.1% (151/154) of students achieved a minimum score of 80% or better on all assessments in PAS 5100, PAS 5200, PAS 5300, PAS 5400 to PAS 5409, HLH 5700, and HLH 5320. Methods of assessment include written examinations, reflection paper, professionalism rubric, discussion boards, and a community service project. 100% (59/59) of students achieved a minimum score of 3.5/5 or better on a Likert scale on each EOR preceptor evaluation of professionalism in PAS 5400 to PAS 5409. One student in the clinical year cohort has not completed all rotations due to LOA. 69.5% (107/154) of students were members of the Michigan Academy of Physician Associates and 61.0% (94/154) were members of the American Academy of Physician Associates.

In response to these results, one student was dismissed from the program in accordance with PA program policy. The PA program continued to enhance the PA Peer Educator services in partnership with the CHP Assistant Dean for Student Academic Success. The program restructured the PAS 5100, 5200, and 5300 course and created fewer sections taught by consistent faculty to improve continuity in education for students. The PA Program continued to develop the faculty line with partial workload to develop a structured premediation and remediation program for students. The number of didactic year dismissals went down from the previous academic year (3 students to 1 student), suggesting success with this program. The PANCE pass rate continues to improve from previous academic years, with the current pass rate at 100% with 5 students left to complete the examination. The clinical year students are required to attend a PANCE prep course at the end of their clinical year. Although membership in the William Beaumont Society (WBS) meets the benchmarks, the MAPA and AAPA membership rates do not. The membership rates have improved since the previous academic year, likely in part due to WBS board members' efforts during orientation to recruit new student members for MAPA and AAPA. Faculty will continue to discuss the benefits of MAPA and AAPA throughout the didactic year. Students are also encouraged to attend the state and national meetings for these organizations and given excused absences from class to attend
