University of Detroit Mercy Religious Discount Tuition Remission Policies

- The 50% tuition discount applies to the populations listed below and is a discount to tuition only, fees are not included. This discount may not be combined with any other UDM scholarship, grant, tuition remission or tuition discount.
- Eligibility is limited to religious, clergy, lay persons serving a parish or congregation **full-time**, enrolled in courses directly related to their ministerial work (ex. Religious Studies).
- **Part-Time and Volunteer** students in one of these positions must show evidence of a substantial quantitative and qualitative commitment to their ministerial work. Typically this commitment should include assigned ministerial responsibilities, a minimum of 20 hours per week watching the ministry and 1 year previous service. **A letter from your ministry is required to verify this.**
- If enrolled in a program not related to your ministerial work you must demonstrate that the courses are relevant to your current ministry.
- Student must be admitted and in good academic standing at UDM in an academic program including undergraduate, post-degree and graduate courses. Professional programs at the Dental and Law Schools, Doctoral Programs, Reduced Rate Workshops and MBA Programs are not eligible.
- This completed form along with a letter signed by the ministry on letterhead verifying full-time participation in the capacity listed above, by the deadlines on this form. This form MUST be submitted each term by the following dates:
